SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Updates and further discussions will be held with stakeholders throughout the grant period. This will include our School Board meetings, PTA meetings and faculty meetings.

With the use of these multiple data points, we are able to assess, identify, monitor and execute academic intervention and Special Education services in ELA and Mathematics to our at-risk populations. Through careful monitoring, the School is able to identify students that require additional summer support and are recommended for summer school. The School recognizes the need for continuous learning for students and to close the achievement gap for these at-risk populations which has been widened due to the pandemic.

The School recognized the impact of lost instructional time and beginning summer 2021 has implemented a summer school learning and enrichment program. This program will continue through summer 2024. The total anticipated costs of this program is expected to meet or exceed the 20% learning loss requirement.

Words Their Way was used as an evidenced based approach to bridge the gap of lost instructional time. This is a word study program that targets skills students that haven't reached benchmark in. Students also received instruction in fluency building. Studies have shown that students that have good fluency develop good reading skills.

HCCS has also hired an additional Special Education Teacher. Hiring an additional Special Ed teacher allows us to assign less students to each respective Special Ed teacher. When teachers work with smaller groups or with individual students they have a greater impact on student progress. Furthermore, hiring the additional Special Ed teacher gave us the opportunity to have the teachers service in one content area (Math or ELA) and a specific grade band, making them "experts" in the respective area and cohort they are servicing. Finally, the additional Special Ed teacher allows for more time in their schedules to have common planning meetings with the Gen. Ed teachers to discuss and preview upcoming units and skills needed to succeed.

All funds are being utilized to address the academic impact of lost instructional time as described in the response to Question 5.

- 7. Funds were allocated towards summer school and an additional Special Education teacher.

Students that had not met benchmark levels in Reading and Math were invited to summer school.

Of the students that attended, 75% were Economically Disadvantaged, 25% were students with disabilities and 8% were English Learners. Initially, students were assessed and instruction was targeted to meet the students' individual needs. We were able to hire enough staff so that instruction was in small groups and that all students received the individualized attention they needed. Staff assessed students' emotional health daily by asking students to reflect on their learning for the day.

In Math, students worked specifically on their math fluency. Mastering this skill for their grade level helps children gain confidence in math and excel in other areas of math.

In Reading, students worked on foundational skills, including fluency and sight word recognition, and comprehension skills. 58% of the students were able to improve their reading level while 42% were able to maintain their reading level.

Hiring an additional Special Education teacher and growing our Special Ed Department ensures that all our students with disabilities will have the opportunity to make maximum progress as literacy and math learners. Hiring the additional teacher, allows us to be more flexible with scheduling so that teachers have time embedded in their schedules to collaborate with their general education partners in designing and providing appropriate instruction and supports for students with IEPs. Through this collaboration, student goals will be identified and worked towards by both the General Ed teacher and the Special Ed teacher.

Our summer school program included low-income families, students of color, English learners, children with disabilities. The School does not currently have enrolled students experiencing homelessness, children in foster care, and migratory student.
