**SUMMARY & BACKGROUND**

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

***ARP-ESSER Application – Part 1:*** The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

***ARP-ESSER Application – Part 2:*** The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The federal ARP statute requires SEAs to reserve:

not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. With the use of these multiple data points, we are able to assess, identify, monitor and execute academic intervention and Special Education services in ELA and Mathematics to our at-risk populations. Through careful monitoring, the School is able to identify students that require additional summer support and are recommended for summer school. The School recognizes the need for continuous learning for students and to close the achievement gap for these at-risk populations which has been widened due to the pandemic.

*Although HCCS offered a summer school program for promotion in doubt students, the school recognized the impact of lost instructional time during the pandemic and beginning summer 2021 has implemented an enhanced summer school learning and enrichment program. This program will continue through summer 2024. We have added, to address the academic needs, an additional Special Ed Teacher, and teacher assistant to help support lower elementary. In addition, we have hired an additional IT assistant to help support the technology needs for these students to ensure one-to-one devices for all students. The total anticipated costs of this program is expected to meet or exceed the 20% learning loss requirement.*

*The majority of the remaining funds are allocated towards salaries and benefits of new positions created for Special Education and Academic Intervention Services, along with partial salaries for IT staff that work on setting up remote learning and preparing devices for in person as well as remote learning when required.*

7. In the space provided below, please describe how the LEA will ensure that the interventions it implements, including but not limited to the interventions implemented under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time, will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

Funds were allocated towards our summer school program, an additional Special Education teacher, teacher assistant in 2nd grade and Guidance Counselor. These new positions were intentional and focused to meet the needs of our population and to minimize the impact of remote/blended learning over the past two school years.

**Summer School** - Offered to students who required additional support, especially those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

Students that had not met benchmark levels in Reading and Math were invited to summer school in grades 1 - 8. We were able to offer summer school intervention to 109 students. These students reflected our most at-risk students with a blend of title 1, special education and students receiving academic intervention services during the school year.

Students were assessed and instruction was targeted to meet the students' individual needs. We were able to hire enough staff so that instruction was in small groups and that all students received explicit attention they needed.

**MATH** - students worked specifically on their math fluency as mastering this skill for their grade level helps children gain confidence in math and excel in other areas of math.

**READING** - students worked on foundational skills, including fluency and sight word recognition, and comprehension skills.

**Special Education:** Hiring an additional Special Education teacher and growing our Special Ed Department ensures that all our students with disabilities, and students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students. will have the opportunity to make maximum progress as literacy and math learners. Hiring the additional teacher allows us to meet the needs of our special education population so that teachers have time embedded in their schedules to collaborate with their general education partners in designing and providing appropriate instruction and supports for students with IEPs.

Through this collaboration, student goals will be identified and worked towards by both the General Ed teacher and the Special Ed teacher.

**Guidance Counselor:** We hired an additional Guidance Counselor to support our students and to ensure an effective roll out of our enhanced and revised SEL (Social Emotional Learning) programs, identifying those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students. We understood the potential need for additional staff to assist in at-risk and crisis counseling with the transition to full remote learning.
